

# **LEGAL TERMS AND CONDITIONS: "SUMMER AGENTS PROMOTION 2025"**

# 1. CAMPAIGN ORGANIZER

These terms and conditions correspond to the "SUMMER AGENTS PROMOTION 2025," a promotion belonging to the company IDS RESIDENCIAL LOS MONTEROS, S.A., with registered office at C/ Ángel Gelán, nº2, 41013, Sevilla, and Tax ID A90212010 (hereinafter referred to as the "Organizer"). These terms and conditions outline the promotion's rules and the conditions for participation.

#### 2. MECHANICS OF THE PROMOTION

  - The client/buyer must sign the reservation document(s) for the property(ies) during the promotion's validity period.
  - The sale of the reserved property(ies) during the promotion's validity period must be completed, meaning the client/buyer must sign the purchase agreement
